

**Sunrise Title I Parent Engagement Plan**

**PART I. General Expectations**

Sunrise Elementary agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.
- The school will notify parents of the plan in an understandable and uniform format and, to the extent practicable, in a language the parents can understand. The plan will be made available to the local community and updated annually to meet the changing needs of parents and the school.

- B. the reciprocal understanding of schools and families that support meaningful parent-school partnerships;
- C. that parents are encouraged to be actively engaged in their child's education and school;
- D. that parents are equal partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

**PART II.** Description of how Sunrise Elementary will implement the required components of the campus Title I Parent Engagement Plan.

1. Sunrise Elementary will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
  - Title I Parent Engagement Advisory Council: These meetings will be offered in English and Spanish and hosted at Sunrise Elementary. Prior to reviewing, discussing and amending the plan, each meeting will offer parents' training on what Title I entails and the importance of parent input. Parents will be selected off a list of parents that have been involved at the school.

2. Sunrise Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
  - Parents will be asked to participate based off level of involvement in the school. Meetings will be in English and Spanish (as needed). Parents will have notes sent home and call outs about different events and trainings at the school.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
  - Meetings will be done after school as needed.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Sunrise Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- This is held during the beginning and end of Meet and Greet that is scheduled before school begins. Parents are also given information from teachers that instruct them to come to the office for a handout on Title I information.

4. Sunrise Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's

curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- This is done during the title one meeting at the beginning of year and during parent teacher conferences.

5. Sunrise Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- These meetings will be held throughout the school year during school events/programs such as the Christmas program, Book Fair, Teacher/Parent conferences, Special Education and 504 meetings, etc.

6. Sunrise Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- We do this every three weeks. We also use DOJO system to update parents about assessments and additional levels of information based off specific classrooms and grade levels.

7. Sunrise Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A
- How to monitor their child's academic progress
- How to communicate with the school
- How to work with educators
- Phone call out system, DOJO, Family Access

8. Sunrise Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Book Fair
- Discovery Center Night
- Skyward Parent Training
- On-line registration

9. Sunrise Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- This will be done during meet and greet, special education meetings, 504 meetings, discipline conferences and teacher/parent conferences. This will also be addressed via call outs as needed.

10. Sunrise Elementary will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Sunrise makes contacts with incoming parents that we are aware of by making sure they know registration dates and meet and greet times for the upcoming year. We have ARDs with Head Start to make sure that students' needs are being met.

11. Sunrise Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Interpreters will be used for special education meetings, teacher/parent conferences, discipline conferences, phone calls and written notes as needed.

### **PART III. Discretionary Components of the Sunrise Elementary Title I Parent Engagement Plan**

Sunrise Elementary may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Providing necessary literacy training for parents from Title I, Part A funds, if the school district has exhausted all other reasonably available sources of funding for that training.
- Paying reasonable and necessary expenses associated with parental engagement activities, including transportation and child care costs, to enable parents to participate in school-related meetings and training sessions.
- Training parents to enhance the engagement of other parents.
- Arranging school meetings at various times, or conducting in-home conferences between teachers or other educators who work directly with participating children, arrange meetings with parents who are unable to attend those conferences at school in order to maximize parental engagement and participation in their children's education.

- Developing appropriate roles for community-based organizations and businesses, including faith-based organizations, in parental engagement activities.
- Providing other reasonable support for parental engagement activities under section 1118 as parents may request.
